**SECTION 2 - HAZARDS IDENTIFICATION**

Emergency Overview

Black. Non-sag gunnable paste. May cause moderate irritation to the respiratory system. May cause nausea, headaches, and dizziness. Leave area to breathe fresh air. Avoid further overexposure. If symptoms persist, get medical attention.

Inhalation : May cause moderate irritation to the respiratory system. May cause nausea, headaches, and dizziness.

Aggravated Medical Conditions

Pre-existing eye, skin and respiratory disorders may be aggravated by exposure.

Chronic Health Effects

As a by product of curing, acetic acid is produced. Acetic acid is a severe eye, skin and mucus membrane irritant and may cause burns with repeated or prolonged contact. Chronic exposure can cause bronchitis and pharyngeal edema. Acetic acid may cause tooth erosion from tooling. Carbon black is classified by IARC to be a known animal carcinogen and a possible human carcinogen (Group 2B). Carbon black is encapsulated by resin and not expected to have adverse effects unless made airborne. Organosilane may cause liver injury with fibrosis after repeated and prolonged overexposure. Fillers are encapsulated and not expected to be released from product under normal conditions of use.

**SECTION 4 - FIRST AID MEASURES**
